Tumors and Osteoporosis represent challenging conditions for spine surgery, particularly when combined. Advances in diagnostic tools and the continuous improvement of surgical techniques positively affect the approach to these problems.

The purpose of this meeting is to update and share experiences and knowledge on these two topics, both singularly and together considered.

This is the first combined meeting of our two Institutions, the National Center for Spinal Disorders (Budapest, Hungary) and the Rizzoli Institute (Bologna, Italy), which represent in the respective countries major centers for reference of these pathologies. The scientific collaboration however has already started since many years, allowing fruitful reciprocal growing.

The format of the meeting includes main lectures and case presentations, with long time available for discussion. Two major worldwide-recognized experts (Ziya L. Gokaslan and Jean Charles Le Huec) will bring their great experience and will offer their opinions and evidences to the discussion.
